### Purpose of this Privacy Policy

This Privacy Policy explains how personal data is collected, processed, stored and protected in connection with the tango events organized by **Društvo Tango Objem Celje**, including:

- Tango Embrace Slovenia
- Abrazo de Invierno Slovenia

We are committed to protecting the privacy and personal data of all participants, guests, partners and visitors in accordance with Regulation (EU) 2016/679 (GDPR).

Personal data is processed lawfully, fairly and transparently, solely for purposes related to event organization and communication.

### What Personal Data We Collect

When registering for our events, we may collect:

- Full name
- Address
- E-mail address
- Telephone number
- Dance partner personal informations
- Dietary requirements or food intolerances (optional)
- Photos or videos taken during events (only with consent)

### Purpose of Data Processing

We process personal data for the following purposes:

- Event registration and administration
- Communication regarding the event
- Room and accommodation organization
- Preparation of invoices
- Special dietary arrangements
- Customer support and complaint handling

- Promotion of our tango events through social media and websites and via e-mail addresses

### **Legal Basis for Processing**

Personal data is processed based on:

- Consent of the participant
- Performance of a contract
- Legal obligations
- Legitimate interest related to event organization

Sensitive data such as dietary requirements are processed only with explicit consent.

### **Photos and Videos**

During our events, photographs and video recordings may occasionally be taken for promotional purposes related to:

- Tango Embrace Slovenia
- Abrazo de Invierno Slovenia
- Social media pages (FB, Instagram, You Tube ...)
- Future event promotion

Photos or videos showing identifiable individuals will only be published with prior consent. Participants may request removal of published material at any time.

### **Facebook and Social Media**

We operate Facebook groups and social media pages for communication and promotion purposes.

### **Data Storage and Security**

We take all reasonable technical and organizational measures to protect personal data against:

- Unauthorized access
- Disclosure
- Loss
- Alteration
- Misuse

Access to personal data is limited only to persons directly involved in event organization.

Cloud services and e-mail providers such as Google/Gmail may be used for communication and secure storage.

### **Data Retention**

Personal data is stored only for as long as necessary:

- Registration and communication data: during event organization and legally required retention periods
- Invoice data: according to applicable tax legislation
- Dietary information: deleted immediately after the event
- Photos/videos: until consent is withdrawn

### **Rights of Participants**

Participants have the right to:

- Access their personal data
- Correct inaccurate data
- Request deletion of data
- Restrict processing
- Withdraw consent
- Object to processing
- Request data portability
